RE: Notification Requirement per Asbestos Hazard Emergency Response Act

Idaho Falls School District 91 is required by 40 CFR Part 763.84, the Asbestos Hazard Emergency Response Act (AHERA) to:

- “Ensure that workers and building occupants, organizations, or parent teacher organizations, are informed at least once each school year about inspections, response actions, and post response actions activities, including periodic re-inspections and surveillance activities that are planned or are in progress.”
- “Ensure that short term workers (e.g. phone repair workers, utility repair workers, or exterminators) who may come in contact with asbestos in a school are provided information regarding the location of asbestos containing building material (ACBM) and suspected or assumed ACBM.”

The following District 91 buildings contain known or suspected asbestos containing building materials and are subject to periodic surveillances every six months:

- A.H. Bush Elementary
- Hawthorne Elementary
- Linden Park Elementary
- Temple View Elementary
- Theresa Bunker Elementary
- Westside Elementary
- Eagle Rock Middle School
- Compass Academy
- Idaho Falls High School Complex
- Skyline High School
- Emerson High School
- RMC A1-A2 at Eagle Rock
- RMC C1-C2 at Eagle Rock
- RMC H1-H2 at Linden Park
- Administration Building
- M&O Building
- District Warehouse
- York Storage
- Food Services Warehouse

Each of above named buildings has an Asbestos Management Plan (AMP) that is available for review. District Operations is in the process of moving the AMPs to the Environmental Safety website located at: <http://www.d91.k12.id.us/asbestos-management-plans>

AMP's can be found on the District website and in each building that contains asbestos building materials. The ES&H Specialist also maintains a copy of the original inspection documents as well as all of the updated plans. The ES&H Specialist's office is located at 625 7th Street Idaho Falls, Idaho.

The Maintenance and Operations Plan, Section IV of the Asbestos Management Plan describes how ACM is contained and maintained to ensure the environment in each building is kept safe. Asbestos surveillances are performed every six months by head custodians and/or trained asbestos inspectors. The three year re-inspections are ongoing, with a portion of the district buildings done each year. These inspections are conducted by accredited School District 91 and/or contractor personnel.

Principals, Directors and Supervisors or their designees are required to inform any outside contractor, repairman, etc., who may come in contact with asbestos containing material or suspect asbestos containing material in an Idaho Falls School District 91 building, of the locations of ACM in that building.

During the calendar year 2017, the following facilities will have asbestos-related work performed:

- 3-year re-inspections will be conducted at Linden Park Elementary School, Relocatable Modular Classroom H1-H2 located at Linden Park Elementary School, Theresa Bunker Elementary School, Compass Academy, Idaho Falls High School, and both the stadiums located at Idaho Falls High School.
- There are potential abatement activities tentatively scheduled for the removal of asbestos-containing floor tile at Eagle Rock Middle School, removal of asbestos-containing floor tile under carpet at Theresa Bunker Elementary, and removal of asbestos-containing floor tile under the carpet at Skyline High School.
- Planned renovation work at Skyline High School and Idaho Falls High School requires that an independent asbestos inspection be performed under the National Emissions Standards for Hazardous Air Pollutants (NESHAP). The NESHAP inspections will be performed in the summer of 2017 to ensure adequate information is available to potential contractors bidding on the renovation work.
